### **2.2:** Recap on the Hughson Farmers' Market/Hughson Concert Series.

City Manager Mendez provided an update on the Hughson Downtown Farmers' Market that would be concluding its second season on September 29, 2016. It was reported that the event was finishing strong with new vendors and greater participation by Market goers during the final month. New elements at the Market included the Jr. Chef Program, Bouncing Bin, etc. The Hughson Concert Series that launched at the Farmers' Market (September 15 in the Downtown and 17 at Starn Park) was also discussed and had been very well received by the community. The event showcased music and a family friendly environment.

### **2.3** Update on the Hughson Christmas Festival.

Business Member Assali provided an update on the Hughson Christmas Festival that was scheduled for December 3, 2016 and would include vendors, parade, decorating contest, tree lighting, music, etc. It was reported that a planning committee of the Hughson Chamber of Commerce had been meeting to build on last year's remarkable success.

### **2.4** CA Luxury Auto Detailing Business Assistance Request (Introduction).

City Manager Mendez shared that there was interest by CA Luxury Auto Detailing to submit a funding proposal for EDC consideration in the new future. It was reported that the owner was working with the Community Development Director and the Hughson SBDC Consultant on a proposal that would consider making improvements to the building to support the current business and possibly bring a new complementary element. The proposal would be submitted once it was fully developed. City staff also shared that it was reviewing the utility charges for the business to ensure that they were being still applied accordingly.

### **2.5** Update on City's Business Development/Attraction Efforts.

City Manager Mendez reported that the City Council would be exploring expanding the services provided locally through Opportunity Stanislaus and the Small Business Development Center. He also shared that the support through Opportunity Stanislaus for the City of Hughson and its economic development efforts had been excellent and that the staff was very responsive to local needs.

Kurt Clark, Opportunity Stanislaus - Chief Innovation Officer & SBDC Director, provided an update on Opportunity Stanislaus. He shared some opportunities to bring additional business training to the Hughson area. Mayor Beekman indicated that the City had several facilities that could be utilized to host business seminars or trainings (City Hall, Senior Center, Third Street Center, Samaritan Village).
