2. NEW BUSINESS:

2.1: Approval of Minutes of the September 26, 2016 EDC Regular Meeting.

2.2: Debrief/Direction on the Hughson Downtown Farmers' Market.

An update was provided on the Hughson Downtown Farmers' Market. It was generally agreed that the market had finished the season strong. The transition to a management team of the City, East Stanislaus Resource Conservation District and a few key vendors at the end of the season worked well. The City Manager recommended that the model continue into the next season. The inclusion of the Junior Chef Program and the coordination with the Hughson Concert Series worked well to bring new elements to the market.

2.3 Stanislaus County Economic Development Strategic Plan/SWOT Analysis.

The City Manager shared information regarding a meeting that he and the Community Development Director had attended with Opportunity Stanislaus (formerly Stanislaus Business Alliance). It was reported that the County was interested in revising the Countywide Economic Development Strategic Plan prepared in 2007 and working with the cities to ensure that there was regional alignment. Opportunity Stanislaus staff would be working with each individual city to revisit countywide and local strategies in the area of economic development.

2.4 "How to Develop Your Retail Recruitment Roadmap" Handout.

The City Manager shared a handout that he had received at the League of California Cities Annual Conference which highlighted successful approaches across the state for retail recruitment.

2.5 Update on Opportunity Stanislaus/Hughson SBDC.

The Hughson SBDC Consultant shared information regarding his sessions with existing and prospective business owners. He also highlighted the Exporting Expo being planned for March 2017 in Hughson at Samaritan Village.

2.6 Update on City's Business Development/Attraction Efforts.

City staff shared information regarding local efforts. This included updates on the expansions of Agave Azul, Coco's Taqueria and Golden Bowl Restaurant. An update was provided on CA Luxury Auto Detailing and some ideas for improvements to their current location and business model.
