Staff Recommendation:

Recommend that the City Council adopt Resolution No. <u>2020-XX</u> to authorize City staff to apply for the Per Capita Grant Funds through Proposition 68.

Background and Overview:

The Per Capita Program originates from Proposition 68, the California Parks and Water Bond Act of 2018. This Proposition was passed for the development and enhancement of State and local parks and recreational facilities. The Per Capita Program has made funds available for local park rehabilitation, creation, and improvement grants for local governments on a per capita basis. Per Capita grants are encouraged to be used to rehabilitate existing infrastructure and to address deficiencies in neighborhoods lacking access to the outdoors. In order to receive the Per Capita grant, a resolution authorizing City staff to apply for the grant money must be approved by the City Council. This Resolution does not authorize a specific project; rather it only authorizes staff to apply for the grant once a project is identified.

Staff will return with a proposed project at a later time.

Fiscal Impact:

The exact amount of funding is not known at this time. However, the minimum grant amount the City can receive is \$200,000 in one-time funding. Since City parks are not located in a "severely disadvantaged" area, meaning the median household income is less than 60% of the statewide average, the City is required to provide a 20% match in funding. That means the City will need to contribute at least \$40,000 to any project funded by the Per Capita grant. It is City staff's recommendation that the Park Development Impact Fee account be used to leverage this State Per Capita funding.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUGHSON APPROVING APPLICATION FOR PER CAPITA GRANT FUNDS

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Per Capita Grant Program ("Program"), setting up necessary procedures governing application(s); and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the grantee's Governing Body to certify by resolution the approval of project application(s) before submission of said applications to the State; and

WHEREAS, the grantee will enter into a contract with the State of California to complete project(s) subject to the Program;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hughson hereby:

- 1. Approves the filing of project application(s) for Per Capita program grant project(s); and
- Certifies that said grantee has or will have available, prior to commencement of project work utilizing Per Capita funding, sufficient funds to complete the project(s); and
- 3. Certifies that the grantee has or will have sufficient funds to operate and maintain the project(s), and
- 4. Certifies that all projects proposed will be consistent with the park and recreation element of the City of Hughson's general or recreation plan (PRC §80063(a)), and
- 5. Certifies that these funds will be used to supplement, not supplant, local revenues in existence as of June 5, 2018 (PRC §80062(d)), and
- 6. Certifies that it will comply with the provisions of §1771.5 of the State Labor Code, and
- 7. (PRC §80001(b)(8)(A-G)) To the extent practicable, as identified in the "Presidential Memorandum--Promoting Diversity and Inclusion in Our National Parks, National Forests, and Other Public Lands and Waters," dated January 12, 2017, the City of Hughson will consider a range of actions that include, but are not limited to, the following:
 - (A) Conducting active outreach to diverse populations, particularly minority, low-income, and disabled populations and tribal communities, to increase awareness within those communities and the public generally about specific programs and opportunities.
 - (B) Mentoring new environmental, outdoor recreation, and conservation leaders to increase diverse representation across these areas.

- (C) Creating new partnerships with state, local, tribal, private, and nonprofit organizations to expand access for diverse populations.
- (D) Identifying and implementing improvements to existing programs to increase visitation and access by diverse populations, particularly minority, low-income, and disabled populations and tribal communities.
- (E) Expanding the use of multilingual and culturally appropriate materials in public communications and educational strategies, including through social media strategies, as appropriate, that target diverse populations.
- (F) Developing or expanding coordinated efforts to promote youth engagement and empowerment, including fostering new partnerships with diversity-serving and youth-serving organizations, urban areas, and programs.
- (G) Identifying possible staff liaisons to diverse populations.
- 8. Agrees that to the extent practicable, the project(s) will provide workforce education and training, contractor and job opportunities for disadvantaged communities (PRC §80001(b)(5)).
- 9. Certifies that the grantee shall not reduce the amount of funding otherwise available to be spent on parks or other projects eligible for funds under this division in its jurisdiction. A one-time allocation of other funding that has been expended for parks or other projects, but which is not available on an ongoing basis, shall not be considered when calculating a recipient's annual expenditures. (PRC §80062(d)).
- 10. Certifies that the grantee has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Procedural Guide; and
- 11. Delegates the authority to the City Manager or his designee to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the grant scope(s); and
- 12. Agrees to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines.
